- Licensed Electrician's Assessment (LEA) (completed within the last 5 years)
- Capstone Assessment – transcript required showing modules
- Technical Experience - To apply under technical experience written references must be provided from past/current employer(s) to cover employment for a period of approximately 10 years (**post 2007**) to demonstrate that you have been actively working as an electrician. References must be provided on company letterhead, dated and signed (by a technical supervisor/manager) and include:
 1. period of employment, and
 2. a detailed breakdown of the type of hands-on electrical installation experience obtained
