Application Process

- 1. Complete the application form and return it to Energy Safe Victoria by email assessmentaudit@energysafe.vic.gov.au **together with relevant supporting evidence**.
- 2. Energy Safe will acknowledge receipt of the application.
- 3. Energy Safe may request further information from the applicant if required. If the required supporting documentation is not provided within one (1) month of the application being submitted, the application case will be closed, and a new application will need to be submitted when all supporting evidence is available.
- 4. Energy Safe shall process the application and provide a decision to the applicant within ten (10) business days from receipt of the fully completed application form and required supporting evidence. Only applications with the required supporting evidence can be processed.
- 5. Applicants will be advised in writing or via email of the outcome of their application.
