- Successful completion of the <u>Licensed Electrician's Assessment (LEA)</u> or interstate Capstone Assessment (transcript required showing modules) completed within the last 5 years
- Having served as a technical supervisor for an REC within the last 5 years
- Technical Experience To apply under technical experience written references must be provided from past/current employer(s) to cover employment for a period of approximately 5 years, to demonstrate that you have been actively working as an electrician and have current and relevant technical experience. References must be provided on company letterhead, dated and signed (by a technical supervisor/manager) and include:
 - 1. period of employment, and
 - 2. a detailed breakdown of the type of hands-on electrical installation experience obtained
